Bureau and Guangzhou Municipal Administration of Taxation under

State Taxation Administration on the Implementation of Relevant

Matters Concerning the Handling of Registration of Immovable

Property Transfer Between Enterprises in "One Link"

S.G.H.Z.Y.Z. [2020] No. 3

All district branches of the Planning and Natural Resources Bureau, tax bureaus of all districts, and Municipal Immovable Property Registration Center,

In order to further optimize Guangzhou's business environment for registering property, improve the immovable property registration service level for the convenience of the general public and enterprises, strictly implement the handling of whole process of registration of immovable property transfer between enterprises in "one link", and realize the "on-site processing via one window by submitting one set of materials and interacting with one person" for the whole process including the acceptance of registration of immovable property transfer between enterprises, taxes and fees verification and payment and certificate collection, we hereby give the notice as follows regarding the relevant matters:

- I. Special windows (zones) for enterprise services shall be set up in all immovable property registration service halls, with eye-catching colors and signs for publicity and guidance purpose, to facilitate enterprises to identify clearly and process the business. The number of special windows should be adjusted in a timely manner depending on the practical situation, so as to meet the enterprises' business needs to the fullest extent.
- II. The registration of immovable property transfer between enterprises shall all be

included in the service scope of the special windows for enterprise services and shall

enjoy the whole-process green channel service. In principle, all the enterprises that

apply for the said kind of business can enjoy special window service. The registrars

and tax staff should clearly guide the enterprises to the special windows for the said

kind of business, and neither the number taking by appointment nor the number taking

on site shall be required.

III. The staff at the special window shall be responsible for collecting all application

materials on immovable property transaction, registration and taxation (the materials

that have already been provided for shared use shall be exempted from collection, the

common materials shall be exempted from repeated collection. As the online contract

signing for stock non-residential property transaction between enterprises has been

cancelled in the city, enterprises can submit the trading contract signed by themselves),

providing guidance on taxes and fees payment, examining the source of ownership of

immovable property, the legality of the transaction, the subject qualification of both

transaction parties, and examining whether mortgage sequestration and other

restriction circumstances exist, and shall ensure handling of application in one hour

and issuance of certificate via the same window.

IV. The instant completion of taxation for enterprises' tax-related immovable property

registration business shall be achieved at the special windows for enterprise services

so as to avoid additional processing steps and avoid the applicant from running back

and forth.

V. The special windows for enterprise services shall also provide services like

immovable property registration, tax-related business consultation and the acceptance

of applications with materials missing.

Processing Steps of Registration of Immovable Property Transfer between Enterprises

Step	Matters to be processed	Processing time
1	Applying for immovable property registration, paying for taxes	0.5 day
	and fees, and colleting certificate on site

	including its independently signed trading contract to one same	
	handling personnel at the special window for enterprise services	
	in the immovable property registration service hall; upon review	
	and collection of relevant taxes and fees, the handling personnel	
	approves the application for registration, and then issue	
	immovable property ownership certificate on site at the special	
	window.)
