Measures of Haizhu District of Guangzhou for the Implementation of the Talent Green Card System

Chapter 1 General Provisions

Article 1 According to the requirements of the *Notice of the General Office of the People's Government of Guangzhou Municipality on the Release of the Measures for Implementation of the Guangzhou Talent Green Card System* (Sui Fu Gui Ban [2023] No. 10, hereinafter referred to as the "Municipal Implementation Measures") and on the basis of the actual conditions of the district, these measures are hereby formulated.

Article 2 Domestic and foreign outstanding talents who start a business or work in Haizhu District of Guangzhou and are not registered permanent residents of Guangzhou may apply for Guangzhou Talent Green Card (A Card or B Card, as appropriate) in accordance with these Measures.

Chapter 2 Qualification for Application

Article 3 Any talent who meets the conditions stipulated in this Chapter (except for Item (iii), Article 5) may apply for Guangzhou Talent Green Card (A Card or B Card, as appropriate).

Article 4 Domestic and foreign outstanding talents who meet the needs of the economic and social development of Haizhu District, start a business or work in Haizhu District for more than 6 months every year, have legal residence in Guangzhou and meet one of the following conditions, may apply for B Card in accordance with Paragraph (iv), Article 5 of the Municipal Implementation Measures.

(i) Personnel holding senior management or technical backbone positions in the following entities:

1. Owners of key construction projects in Haizhu District and of key projects in Haizhu District that aim to promote the construction of the Guangdong-Hong Kong-Macao Greater Bay Area in the current year;

2. Key supported industrial enterprises in Haizhu District, including enterprises headquartered in Haizhu District, urban industrial enterprises, specialized, refined, distinctive and innovative enterprises, listed enterprises, high-tech enterprises, integrated circuit enterprises, enterprises in industrial internet and exhibition industries;

3. Key foreign-invested enterprises in Haizhu District;

4. Key artificial intelligence and digital economy enterprises within Pazhou Core Area of Guangzhou Artificial Intelligence and Digital Economy Experimental Zone (excluding Guangzhou Higher Education Mega Center);

5. Key human resources service institutions in Haizhu District.

The list of the above-mentioned five kinds of entities and talents will be determined through discussion by the Haizhu District Bureau of Development and Reform, the Haizhu District Bureau of Science, Industry, Commerce and Information Technology, the Haizhu District Bureau of Investment Promotion, the Pazhou Management Committee and the Haizhu District Bureau of Human Resources and Social Security.

(ii) Talents supported by relevant policies of Haizhu District.

(iii) For talents who have made outstanding contributions to the economic and social development of Haizhu District or meet the development needs of Haizhu District and are urgently

needed and in short supply in Haizhu District, the application qualifications may be appropriately relaxed after being approved by the Talent Work Leading Group directly under Haizhu District Party Committee.

Chapter 3 Application Process

Article 5 The application for a talent green card adopts whole-process online handling procedures. Talents who meet the application qualifications herein may apply for A Card or B Card as follows:

(i) Application. The applicant may log in to the Guangzhou Talent Green Card Management System or Suihaoban APP and apply according to the relevant process guidelines.

(ii) Verification. The District Bureau of Human Resources and Social Security will complete the verification within 5 working days from the date of receiving the application materials. In case of any doubts about the application materials, the applicant shall accept the checking of such materials.

(iii) Making the green card. Where it is determined that the applicant meets the conditions, the department in charge of making green cards as specified in the Municipal Implementation Measures shall complete the card making within 5 working days.

(iv) Issuance of green card. After completing the making of the talent green card, the applicant may choose to get the card on-site at the designated issuance location or by mail with freight to be collected at destination, and the District Bureau of Human Resources and Social Security will simultaneously issue the electronic certificate.

Chapter 4 Supplementary Provisions

Article 6 These Measures shall be implemented from the date of release and shall be valid until June 14, 2028. The *Notice of Haizhu District of Guangzhou on the Release of the Measures for the Implementation of the Guangzhou Talent Green Card System* (Hai Ren She Gui [2020] No. 1) shall be abolished accordingly. Any person who has obtained a talent green card is entitled to relevant preferential treatment in accordance with Chapter 3 of the Municipal Implementation Measures during the validity period of the card.

Article 7 When the validity period expires or the policy basis changes, these Measures shall be revised upon evaluation in a law-based approach as per the actual implementation situation. If there is any inconsistency between these Measures and the superordinate regulations due to changes in superordinate laws, regulations, rules and policies, the superordinate regulations shall prevail, the corresponding provisions of these Measures shall be no longer applicable, and the preferential treatment already enjoyed by the cardholder shall not be claimed for refund.

Article 8 The interpretation of relevant terms and additional conditions in these Measures shall be subject to the provisions on Guangzhou talent green card.
